1. Presentation

The Catalan Institute of Classical Archaeology (ICAC) is a public research institution created by the Catalan Autonomous Government and the Rovira i Virgili University. ICAC aims to research, provide training on, and disseminate the protohistoric, classical, and late antique cultures of the Mediterranean and beyond. The Institute is recognized as a research centre in Catalonia, identified as a CERCA centre. ICAC is based in Tarragona and is composed of a team of around 60 individuals, including researchers, staff, and management and administrative staff.

The *Instrumentum domesticum* and Production and Commerce in Antiquity, Late Antiquity, Villae research team, lead by Dr. Ramon Járrega Domínguez, executes the project 'Amphorae ex Hispania 3 (AExH3): el comercio de ánforas hispanas en época romana en el Mediterráneo. Cronotipología anfórica, y relación entre producción y difusión (PID2022-138200NB-I00)', which requires a postdoctoral research hiring.

3. Eligibility

5. Merits

6. Submission of applications

 - 6.1.2. Body of the message: surnames and first name, NIF or passport number, a contact phone number, the academic degree, in addition to stating the will to participate in this job offer.
 - 6.1.3. Attached documents:
 - 6.1.3.1. PDF file with the required degree certification listed in this Call (in Section 1. Eligibility).
 - 6.1.3.2. Curriculum vitae (CV (in a PDF file) related to the job offer.
 - 6.1.3.3. A single PDF file containing the supporting documents corresponding to the merits and experience listed in the CV.
- 6.2. In the curriculum vitae (CV), it is necessary to provide a detailed description of the responsibilities performed in each of the positions held and specify the dates and duration of each contract. Regarding education, it is essential to specify in all cases the duration of the courses in hours, and the type of certification obtained (attendance, attendance with achievement, etc.). Regarding language proficiency, a corresponding

certificate must be provided specifying the level achieved according to the Common European Framework of Reference for Languages (CEFR).

6.3. Deadline for Applications ends on December 26, 2024 at 23:59h.

6.4. Applications that do not meet the eligibility of the call will not be considered.

7. Selection procedure

7.1. The Evaluation and Selection Committee (hereinafter, CAS) will assess the applications based on the CVs. The CAS will consider the best match between the academic background of the applicant and the scientific and technical activities they are required to perform. Additionally, the CAS will score up to a maximum of 100 points in accordance with the following sections:

7.1.1. Participation in scientific congresses/conferences/meetings related to the current research line of the current call (0-20 points)

Oral presentation/speaker..... 3 points.

Participant as an organizer.....1,5 points.

7.1.2. Publication of scientific articles within the line of research that is related to the current call. (0-15 points)

Publication.....3 points

7.1.3. Participation in research projects related to the line of research of the current call. (0-10 points)

Research project.....5 points

7.1.4. Participation in excavations in the area of Hispania Citerior (0-10 points)

Excavation.....1 point

7.1.5. Acceptable knowledge of Catalan (0-10 points)

7.1.6. Acceptable knowledge of English (0-10 points)

7.1.7. Complementary training in the subject related to the current call for applications (0-15 points)

7.1.8. Foreseeable knowledge of Roman archaeology in Spain, particularly in Catalonia (0-5 points)

7.1.9. Knowledge of the production process during the Roman period in Hispania Citerior (0-5 points).

7.2. If deemed appropriate, the CAS may request the necessary documentation to verify the alleged merits, at any time during the processing of the application. Failure to provide the required documentation within the requested period may result in suspension of the application.

7.3. In the event of a tie for the highest score, the CAS will interview each of the matched applicants to better determine the merits and assign the order of precedence between them. If the CAS deems it appropriate, it will also be able to interview applicants who have obtained up to a maximum of 10 points difference, with respect to the candidate who has obtained the highest score. In the interview, the CAS will assess more accurately the merits and abilities determined in the call, especially the skills and knowledge related to section 3. The maximum score of the interview will be 15 points, which is they will have to add to the points obtained in the valuation of the rest of merits. If the interview score requires it, the maximum score of 100 points may be exceeded.

7.4. Applications that do not score 60 points on the evaluation cannot be selected or included in the booking list.

- 7.5. The selection process will take place after the closure of the admission of applications, and it is expected to be resolved in January 2025. The date of incorporation is expected to be in January 2025.

8. Personal data

- 8.1. By formalizing and submitting the application, the applicants accept the rules of the call and give their consent for the processing of the necessary personal data to take part in the call, and for the rest of the processing of the selection process or other actions that derive from it, in accordance with current regulations.

9. Follow-up of the call according to the hiring principles at the ICAC

- 9.1. This call is based on compliance with the principles approved by the ICAC in the framework of the OTM-R program for the accreditation of HRS4R.
