Institut Català d'Arqueologia Clàssica (hereafter "ICAC"), Deutsches Archäologisches Institut, implementing unit Wissenschaftliche Abteilung der Zentrale (hereafter "DAI)" and Leibniz-Zentrum für Archäologie (hereafter "LEIZA") believing the extension and strengthening of scientific exchange to be mutual value to their institutions and the development of understanding between our peoples, hereby record their intentions to promote academic exchange between their institutions through the following activity.

The partners would welcome further opportunities for young scientists to benefit from the mutual possibilities arising from this collaboration.

1. The purpose of this cooperation agreement is to regulate the guest stay of young researchers in the post-doctoral phase who have been awarded the 'Premio de Investigación en Arqueologia Clásica «Antonio Peña Jurado»' by the ICAC at one of the two German partner institutions for the purpose of postdoctoral study or research.

2. The guest stay at DAI or LEIZA is limited to one visiting scholar per year and has a maximum duration of one month. The decision as to which host institution, DAI or LEIZA, will depend on the capacity of the host institution.

3. The date of the guest stay is flexible and is determined by the host institution, DAI or LEIZA, on a case-by-case basis according to its capacities.

4. Visiting scholars will be selected by the ICAC subject to prior approval of the host institution.

5. The host institution provides free accommodation in its guest house and provides library and research facilities at the host institution.

6. The ICAC, through its research groups, covers the visiting scholars's travelling expenses to the destination city in Germany.

7. The collaboration between ICAC, DAI and LEIZA should be mentioned in all publications or activities resulting from the guest stay.

8. Neither party will have any financial obligation or liability to the other, or to any scholar from the other party visiting under this Agreement. The costs are borne by each party itself.

9. This agreement enters into force on the date of signatures and has a term of 5 years. It will be subject to review after a term of 3 years. It may be terminated in written form by one party prior to the expiration of this agreement by giving 6 months in advance. Already on-going activities under this agreement shall not be affected by the termination.

10. The agreement may be extended at a later date to include other German partner institutions. This extension must be agreed by all parties.

11. Any renewal shall be signed by an authorized representative of each party, and may include variations of this agreement.

12. Solutions will be sought in a spirit of good collaboration for any problems arising from this agreement.
